AMENDMENT TO BY-LAWS FOR GREEN MEADOWS NORTH HOMEOWNERS' ASSOCIATION

Lot (1-40) Green Meadows North Plat 2, Lot (42) Green Meadows North Plat 3, Lots (1-51) Green Meadows North Plat 4, Lots (1-37) Green Meadows North 5, Lots (1-23) Green Meadows North Plat 6, Lots (1-9) Green Meadows North Plat 7, Lots (1-16) Green Meadows North Plat 8, Lots (1-38) Green Meadows North Plat 9, Lots (1-31) Green Meadows North Plat 10, Official Plats, now included in and form a part of the City of Johnston, Polk County, Iowa

**NOW, THEREFORE**, the undersigned hereby declare that all of the properties described above shall be held, sold and conveyed subject to the following By-law, covenants, and conditions which are for the purpose of protecting the value and desirability of, and which shall run with, the real property and be binding on all parties having any right, title and interest in the described property or any part thereof, their heirs, successors, and assigns, and shall inure to the benefit of each owner thereof.

1. Article V, Section 4 QUORUM of the By-laws is hereby amended by deleting the current By-law provision and inserting in lieu thereof the following:

The presence at the meeting of 10% of the Members entitled to vote or present by proxy shall constitute a quorum for any action except as otherwise provided in the Articles of Incorporation, the Declaration, or these By-Laws. If, however, a quorum shall not be present at any meeting, the Members entitled to vote shall have power to adjourn the meeting another time without further notice other than announcement at the meeting.

2. In accordance with Article XIV, of the Bylaws, this By-law amendment has been adopted by the Green Meadows North Homeowners' Association Board of Directors at a regular meeting upon the affirmative vote of a majority of the Board of Directors present.
