Current Financial Status:

- 3 CD's, currently valued at \$33,456.00, \$33,496.00, and \$25,000.00
- Current Status at Grinnell Savings Bank: Checking = \$4,122.19
- Current Status at Grinnell Savings Bank: Savings = \$81,512.72
- Current Total Liabilities and Equity = \$177,585.91
- Last month \$4,311.50 of expenses
- Operating at budget for 2020
- May be slightly over budget based on projected expenses, based on final 16 days of calendar year

• 6 association members with aging accts receivables = \$725.00

2021 Budget:

- Our initial plan for the 2021 budget was based on an estimated \$200.00 per home in HOA, for total of \$57,200.00
- This budget was developed based accordingly on similar expenses based on previous years, considering insurance, lawn care, landscaping, tree maintenance, mgmt. fees, property taxes, attorney fees, office expenses, website upkeep, bank services, income tax, capital improvements, and other misc. expenses.
- Considering a \$150 fee instead of \$200 would be about \$14,000 short fall to our 2021 budget. Our operating expenses would then fall short.
- Eric recommends we keep our dues consistent with our budget for 2021.
- With that, it gives us the chance to work on enhancing the neighborhood in the way we had hoped to do. IF we cut the dues for the year, we reduce our ability to do these things.
- Dustin keep dues where are, form finance committee
- Chris fine with keeping dues the same; give the finance committee the chance to discuss how we can better use our funds.
- Justin We could possibly show sympathy to homeowners, and do a one-time drop of \$25.00 per home, and reevaluate for 2022.
