  - a. Choosing tree replacements
    - a. A variety provided by Lisa all low maintenance to be between
       Newgate and the sidewalk along the south side of it.

- a. Reaffirmation of Covenants two plats were expiring by next year and the lawyers will have the documents ready by next meeting
- b. Ice Cream Social Participation about 130 people+! Weather was nice overall. Total cost was \$470. Facebook likely helped attract more people this year. Should plan to do that again next year.
- c. Late Fee Legal opinion is that we should stop after first \$25 and then charge interest thereafter, likely remove old late fees from overcharged.
  - a. 12%-15% interest is common at other HOAs. Some manual work for managing it, but likely only a few homes will apply.
  - b. What about next year having a \$50 late fee (since it can only be done once), and then a 1% per month, with a \$5 min each month. And also what about offering a discount to pay by an earlier defined date than by due date. Or to pay online (ACH) to avoid mailings for some??
  - c. 2020 late fee confirmed by board to be \$50, with 1% per month thereafter, with \$5 min each month.
  - d. Could put reminders on FB.

- a. Stump on Newgate end of Newgate entry island, on South. Been there for 3 years, needs to be removed. We will review.
- b. Christmas Lights We just need an electrician out there for an outlet on each island. Al's guy (Mo) is going to call Lisa. No Lisa is going to call Al. Mo will buy them, install them, and store them. Start small with just Newgate entry island and Lyndhurts entry island. And wreaths on entry lights. White lights, to match the street lights.
